



**FAITH BAPTIST SCHOOLS
SUMMER SCHOOL AND/OR DAY CAMP
FINANCIAL CONTRACT AND REFUND
WAIVER**

I understand that the policy of the School is to make no refunds on Summer School and/or Day Camp application and tuition fees. I understand that the application fee paid for each child is to offset services rendered in connection with the processing of my child's application for admission to the Summer School and/or Day Camp. I understand that submitting an application does not guarantee a place in Summer School and/or Day Camp.

In making this application for my child, I affirm that I will be financially and morally obligated to maintain enrollment for my child in the Summer School and/or Day Camp period of which I have applied for on this application. By accepting this obligation, I understand, acknowledge, and assume the financial responsibility for payment in full of all tuition, fees, and other related financial obligations (as stated on this application and in the Summer School and Day Camp Handbook) incurred in connection with the processing and enrolling of my child in Summer School and/or Day Care. I waive and relinquish all right and interest to any refunds on Summer School and/or Day Camp application and tuition fees paid by me to the school in connection with my child. I hereby pledge to pay my financial obligation to Faith Baptist Schools on the date(s) due.

- A \$75 non-refundable Application fee is due at time of enrollment for each child.
- Summer School tuition will be billed through the Parent Portal. Summer School tuition is payable immediately upon receipt of the billing. Summer School students will not be allowed to attend classes unless the Summer School tuition has been paid in full.
- Payment for the Day Camp Weekly Package is due in full at the time of enrollment. Day Camp weeks can be added as needed.
- A \$20 fee will be assessed for each change made to this application.
- Summer School students not enrolled in Day Camp and not attending Day Camp that day must be picked up each day no later than 12:15 PM for elementary academic classes and enrichment classes (elementary and junior high). Academic junior high and senior high students must be picked up by 12:45 PM each day if they are not enrolled in Day Camp and not attending Day Camp that day. Students not picked up by the specified times each day will be charged \$2 for every 1-minute past those deadlines.
- Day Camp students must be picked up each day no later than 6:00 PM. Students not picked up by 6:00 PM each day will be charged \$2 for every 1-minute past 6:00 PM.
- No refunds will be given for unused days or days missed due to illness or vacation.

**IMPORTANT: SIGNATURES OF BOTH PARENTS ARE REQUIRED FOR
ENROLLMENT.**

Both Parent 1 and Parent 2 signatures are required. In the case of sole custody or a deceased parent, please electronically sign as both Parent 1 and Parent 2. Please understand that in the event that parents are divorced with shared custody, both electronic signatures are still required unless one parent has sole legal custody. If a child is not living with either parent, the electronic signature of the child's legal guardian is necessary. In electronically signing this

waiver, I affirm that I have carefully read and fully understand the material and realize that there will be no refunds on application or tuition fees for any reason whatsoever. Any changes made to this Financial Contract may make it impossible to accept your child's application.
